It has been a pleasure to serve as President of our wonderful organization and work with a group of women, both old friends and new, who are such an important part of my professional life. While the SAWH cannot provide tangible returns for membership dues, I hope all of you draw from our organization a sense of strength from similar relationships and appreciate the incredible contributions women have made and continue to make to the profession. We have come a long way from the SAWH's founding forty-one years ago and our first conference in 1988.

I look forward to seeing all of you at the SHA Convention in Baltimore in late October. The highlight for the SAWH will be, of course, our annual celebration—the awarding of book and article prizes, a talk by Dr. Elizabeth Hayes Turner, and a reception organized by SAWH First Vice President Beverly Bond, to be held at the Maryland Women's Heritage Center near the Sheraton Hotel. Check the SHA annual meeting program (pp. 92 and 93) for details. Without giving away particulars of her address here, Liz Turner, Professor of History at the University of North Texas, will share her exciting research on the 1968 Poor People's Campaign. The Campaign was a result of Martin Luther King's and SCLC strategists' efforts to create a more inclusive project to involve African Americans, Hispanics, American Indians, and poor whites. What has intrigued Liz—and what she will share with us—is the role women played in bringing thousands of poor people to Washington D.C. in the summer of 1968 and how they continued to fight for the needs of the poor.

The SAWH Executive Council this year will address a number of issues at our annual meeting including a permanent home for our book collection, the ongoing issue of ways to increase membership, and the need to increase SAWH visibility. We have recently improved our web page, which had outdated information on it and are looking for someone who is more technologically savvy than your current President and Secretary to keep it current. Also, we would like to enhance our Facebook presence. Any ideas you have to improve our outreach efforts and visibility are welcome. Lorri Glover and Rebecca Sharpless are hard at work on the SAWH Ninth Conference to be held June 6 – 9, 2012 at Texas Christian University in Fort Worth. It should be a stimulating and exciting three days.

Call for Manuscripts: Women's/Gender History in the Gilded Age & Progressive Era

The Journal of the Gilded Age and Progressive Era invites submissions for a planned special issue around the theme, "Women's and Gender History in Global Context."

Any subject is welcome, so long as the manuscript in some way addresses the theme; focuses on the period covered by the journal, roughly 1870-1920; and has a U.S. component. Manuscripts may adopt a transnational perspective, view the United States from a comparative or international point of view, or focus on issues of empire. Submissions are welcome from scholars based in the United States or in other countries. Manuscripts will be peer-reviewed, with final contents selected by a committee drawn from the journal's editorial and executive board.

CFP: Book Project

Still Maids? Still Toms?: Perspectives on The Help and Other White-Authored Narratives of Black Life in the 'Post-Racial' Era"

The last decade has seen several very popular depictions of African-American life created by white writers and directors, including *The Help*, *The Secret Life of Bees*, *The Blindside*, *Number One Ladies' Detective Agency*, and others. Editors Claire Oberon Garcia (Colorado College) and Vershawn Ashanti Young (University of Kentucky) seek intellectually informed but accessible written analyses (around 2500-4000 words, around the length of a conference paper or longish editorial) of these narratives that respond to these or other questions: What do these texts—and their appeal-- have to tell us about American life and culture and/or contemporary race and gender relations, at a time when some claim that we are living in a "post-racial" era? How are notions of authorial "authority" inflected by crossing racial lines? How is the history of the Civil Rights movement being revised and rewritten in the age of Obama? What is the role of women's book clubs in creating best-sellers? How do *The Help* and similar texts speak to generations born after the 60s? What is the role of *The Help* and other texts in revisionary Southern history? Is the popularity of such books and films a sign of how far "we" have come— or how much farther American society has to go in the quest for racial equality and justice?

Fifty years after the publication of *To Kill a Mockingbird* changed the hearts and minds of millions of white readers, the novel and film adaptation of *The Help* seems poised to achieve the same canonical and emotional status. For this collection, Garcia and Young invite artists, bloggers, writers, civil-rights activists, cultural critics, journalists, and scholars from all disciplines to provide insight into the hopes, fantasies, fears, and conflicts that inform and emerge from contemporary white-authored narratives of black life.
